Use of the velomobile

The velomobile is operated by NAME First_Name Regions and days:

- France:
 - Région Alsace
- Switzerland:
 - Kanton Basel Stadt
 - Kanton Basel Landschaft
 - Kanton Soloturn
- The maximal days during the Schooldays, and all the days during the Holidays.

Delivery of the velomobile

Color in RAL Auto colors(minimum 2 years agreement).

Customer decide body color, otherwise uses the original body color on the velomobile.

Design material/Profile

Customer pay cost for manufacturing and mounting of material (foil, stickers, . . .).

Full foliage of the velomobile is payed by customer. Non permanent foil is recommended, since strong glue can harm the original paint.

Prices/Modules

The whole velomobile cost $400 \le$ or 500 CHF per month. The customer can also pay $9000 \le$ when the owner get the velomobile, and after the first year pay monthly $250 \le$.

If velomobile is to be transported outside area of contract, the customer pays transport cost and if necessary accommodation and salary for the driver (for example : at events in Weekends).

Salary : 200 € per day.

Responsability

Driver/Owner shall use th velomobile according to the description in Contract. At heavy snowfalls, storms or nature catastrophes, accidents or other unforeseen obstacles, and the velomobile is not in use, the driver have no liability to drive as long as it is risk for injury on person or velomobile.

Driver is responsible to have the velomobile clean for best exposure for the advertisements.

Driving of the velomobile must be done in a way that not put advertiser in a bad light. (N.B. : Hazardous driving).

In case of an accident which destroys the velomobile, the contract can be broken by customer or owner.

Customer must protect the velomobile against damages and theft when the vehicle is at customers property/buildings/stand, etc. Damages caused by customers handling during transport or use that need repair (cost of repairs from damages on body, drive-train/steering, or wheels must be payed by customer).

Security

Driver is responsible for driving the velomobile at all time, and only persons approved by owner can use the velomobile. If driver is representative for the customer, the responsibility follow the driver. The velomobile must be securely locked during daytime and locked inside a building when not in use/during nighttime.

Payment

Customer pays monthly in advance after invoice. Monthly fee contains the tax.

Break of the agreement

If customer or driver breaks the agreement, the other part can stop the agreement. The agreement will still run for 3 months. Both parties in agreement is supposed to solve conflicts along the way.
